The Convenor of the Committee, while welcoming the members, apprised them that the Directorate of IT&SS has ample infrastructure to introduce a new course as per the guidelines of NEP-2020, which emphasize changes to align the programme with industry standards as well as research. The faculty members of the Directorate of IT&SS presented the structure for the introduction of Master's in Information Technology with specialization in Artificial Intelligence & Data Science/Cyber Security, in alignment with the guidelines of NEP-2020.

After a thorough discussion on the above-mentioned subjects, the members recommended/ proposed the following:

1. The Committee unanimously recommended the title of the degree as **Master's in Information Technology with Specialization in Artificial Intelligence & Data Science/Cyber Security**.
2. **The specialization shall be decided by the students in the second Year.**
3. The syllabus for the said programme was recommended as given in **Anexure "A"**.
4. The eligibility criteria governing admission to the said course be prescribed by the University as per NEP-2020. Additionally, the members of the Committee proposed the intake capacity for the programme and the fee structure for the course on a self-finance basis, effective from the academic session 2025 and onwards, as outlined below:

Eligibility	For NEP 2020 or CBSC or semester or Year Wise Scheme Students: For a 2-year (4-semester) Master's degree programme, a 3-Year (6-Semester) Bachelor's Degree with a minimum total of 120 Credits including a minimum of 12 credits in the relevant subject shall be the eligibility criteria for admission.
Intake	50- Seats with annual admission fee of Rs. 49,175/= (including Admission Fee=Rs.6150+ Departmental Fee=Rs.41500 + Library Fee= Rs. 800+ Proctor Fee=Rs.200+ DSW Fee=Rs.75 and Internet Fee=Rs.450).
Mode of Admission	Admission shall be made on the basis of Entrance Test and as per policy of the University of the University adopted from time to time.

AGENDA: To resolve the issue of overlapping of **Course Titles / Content** for the students of Four Year Under-graduate programme (FYUGP) with Major in Computer Applications/Information Technology and Minor in Information Technology/Computer Applications respectively.

RESOLUTION: The sub-committee, constituted in the meeting of Deans of various schools along with the concerned heads of the departments under the chairmanship of Dean Academic Affairs on 22/03/2024 to resolve the above issue, met on 26/03/2024 with Dean, School of Applied Sciences and Technology in Chair. After threadbare discussion it was resolved as under:

1. Students with major in Computer Applications (CAP) shall not be allowed to take minor (CT1) from Information Technology (BIT) and Students with major in Information Technology (BIT) shall not be allowed to take minor (CT1) from Computer Applications (CAP). However,
2. Students with major in Computer Applications (CAP) may opt for minor in Applied Computing (ACP) or Applied Information Technology (AIT).
3. Students with major in Information Technology (AIT) may opt for minor in Applied Computing (ACP) or Applied Information Technology (AIT).

These changes were incorporated to address the issue of overlapping of courses, as per the Curricular Framework appended with these minutes. The implementation of this provision shall have prospective effect as under:

- For the students admitted to FYUGP in 2022 with the above combinations w.e.f. the 4th Semester.
- For the students admitted to FYUGP in 2023 with the above combinations w.e.f. the 2nd Semester.
- For the students to be admitted to FYUGP in 2024 and onwards with the above combinations w.e.f. the 1st Semester.

Thereafter the meeting ended with a vote of thanks to the chair.

The Chairman apprised the members of the Board of Studies that the Chairman has received communication on 04-09-2023, from Dean, Academic Affairs submitted by the different College Principals of Government Degree Colleges of the Kashmir Valley, requested to change the eligibility criteria of the said programme and make 10+2 or equivalent as eligibility. However eligibility criteria governing admission to the said programme has been prescribed by the University as per the New Education policy (NEP-2020) is as under:

“The Candidates who have passed their 10+2 class examination or equivalent with Mathematics/Statistics/Computer Applications/Information Technology/Information Practice shall be eligible for admission to the programme.”

The members of the Committee after examining the status of the matter deliberated at length and in view of the above concern received from the different College Principals of Government Degree Colleges of the Kashmir Valley, It was unanimously resolved and recommended that the eligibility criteria for the **“Bachelors Programme with Major in Information Technology”** may be modified and a new eligibility criteria for the said programme is proposed as under:

“The candidates who have passed their 10+2 class examination or equivalent shall be eligible for admission to the programme.”

The Chairman of the Committee, while welcoming members of the Committee apprised them that the PG Entrance Test Syllabus should be based on the UG syllabus operational for semester system under CBCS pattern containing 15 Units (4 Marks of each unit). Subsequently, the Chairman of the Committee discussed the existing structure of M.Sc. (IT) syllabi and courses of studies under Choice-based Credited System and emphasized upon the change in order to make it at par with the Industry. The Chairman also apprised the members of the Board of Studies that eligibility criteria governing admission to the said course has been prescribed by the University as under:

"B.Sc. IT, BCA/BE/B.Tech. or B.Sc. with Information Technology/ Mathematics subject/discipline having least 24 credits either as Core or as Generic Elective (Honours) at UG Level under CBCS Scheme or B.Sc. in any stream with Mathematics at 10+2."

The chairman of the Committee also apprised the Committee about the communication received from Assistant Registrar, Academic, University of Kashmir forwarded by Divisional Commissioner, Kashmir regarding the implementation of Syllabus of Cyber Security Course at Undergraduate and Postgraduate Level.

The faculty members, of Directorate of IT&SS presented the PG Entrance syllabi and existing structure of the M.Sc.(IT) syllabi & courses of studies under Choice-based Credited System which is applicable to course from 2018-2022. After having a thread-bare discussion on the above mentioned subjects, the members unanimously recommended that:

1. The syllabus for PG entrance test for admission to M.Sc. (IT) already in vogue is suitable and already in sync with the Undergraduate syllabus operational for semester system under CBCS pattern containing 15-Units. As such no change is recommended in the PG entrance test syllabus.
2. In order to tune the M.Sc.IT syllabi in cognizance with industry, the few courses in the entire syllabi were restructured keeping in mind various specializations possible in Information Technology, forming Annexure "A" to these Minutes. The Committee also stressed upon the introduction of Cyber Security at Postgraduate level in tune with the UGC Choice-based Credit System.
3. The eligibility criteria for the M.Sc.(IT) Course needs to be modified and a new eligibility criteria for the said course is as under:

"B.Sc. IT or BCA or B.E/ B.Tech (Computer Science Engineering/Electronics & Communication/ Information Technology) or B.Sc/B.Tech. With Information Technology/Mathematics subject/discipline having least 24 credits either as Core or as Generic Elective (Honours) at UG Level under CBCS Scheme or B.Sc.in any stream with Mathematics at 10+2."

The meeting concluded with a note of thanks to the Chair.
