- b. The appointee(s) shall have to necessarily work for a priod of five (5) years on the post against which he/she has been appointed and such appointee(s) shall not be eligible for transfer for whatsoever reason during the temporary service of five years.
- c. That any person appointed against any available vacancy on the basis of being a resident of backward area or an area adjoining the Line of Actual Control shall serve in such area for a period of not less than seven (7) years.
- d. That during the period of first five years, the appointee shall be entitled to the minimum of the scale of pay, along with the grade pay, applicable to the post against which he/she is appointed.
- e. That the appointee(s) shall be entitled to annual increments, Dearness Allowance,
 House Rent Allowance and City Compensatory Allowance after successful
 completion of their five years of service on consolidated salary.
- f. That the appointee(s) shall be entitled to the benefits under the Medical Attendance Rules and Leave Rules from the date of their appointment itself.
- g. That the seniority of the appointee(s) shall be reckoned from the date of their appointment.

- h. That the period spent on probation/ consolidated salary shall also reckon for purpose of calculating the qualifying service of these appointees for pension and other benefits provided under SRO-202 of 2015 dated 30.06.2015.
- i. That in the matter of other conditions of service like age, qualification, discipline, conduct and other allied matters, a person appointed under these rules shall be governed by the recruitment rules of the service to which the post occupied by him belongs, besides, other rules, regulations and orders in vogue of the State Civil Services in general.
- j. That the appointee (s) shall report within a period of 21 days from the date of issuance of this order to the concerned Directorates of School Education, failing which their appointment shall be treated as cancelled without any notice.
- k. That the salary of the above appointee (s) shall not be drawn and disbursed unless and until his/her character/antecedents are received from CID Headquarters and authentication of qualification/ other allied documents from the concerned issuing agency/agencies.

The Directors of School Education Kashmir/Jammu are directed to issue posting orders in respect of those appointees who join, immediately to ZONE-III areas as notified in Para-5 of Government Order No. 622-Edu of 2015 dated 22.12.2015 against available vacancies wherever these vacancies exist, and thereafter against those who are presently posted in ZONE-III areas beyond one year.

The Directors of School Education, Kashmir/ Jammu shall, however, report those appointee(s) who do not join within 21 days and will simultaneously issue public notice through print/ electronic media giving last and final opportunity to those who do not join, so that waiting list adjunct to select list is operated.

The appointments of above candidates will also be subject to the outcome of the writ petition(s), if any, pending before any Hon'ble Court of Law.
